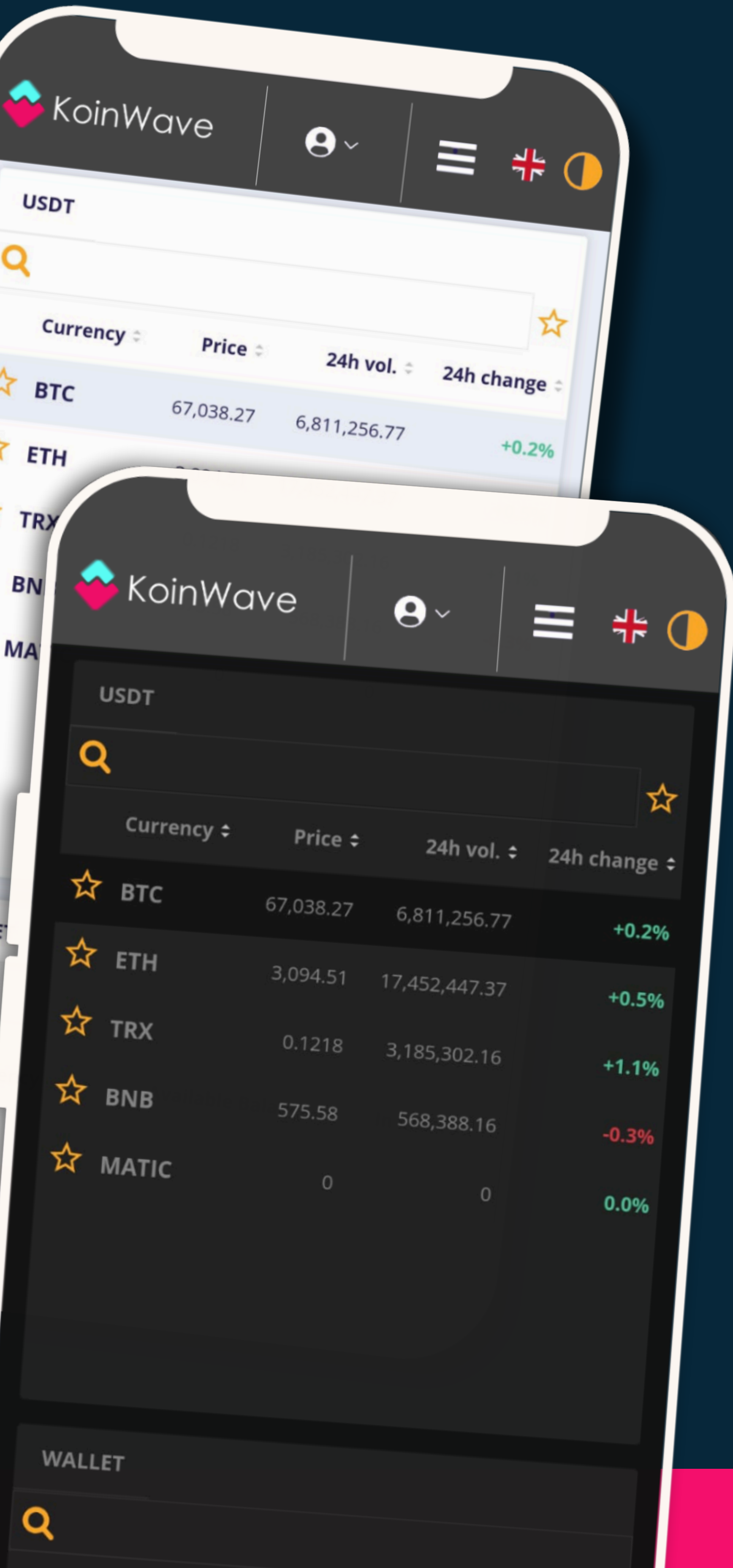

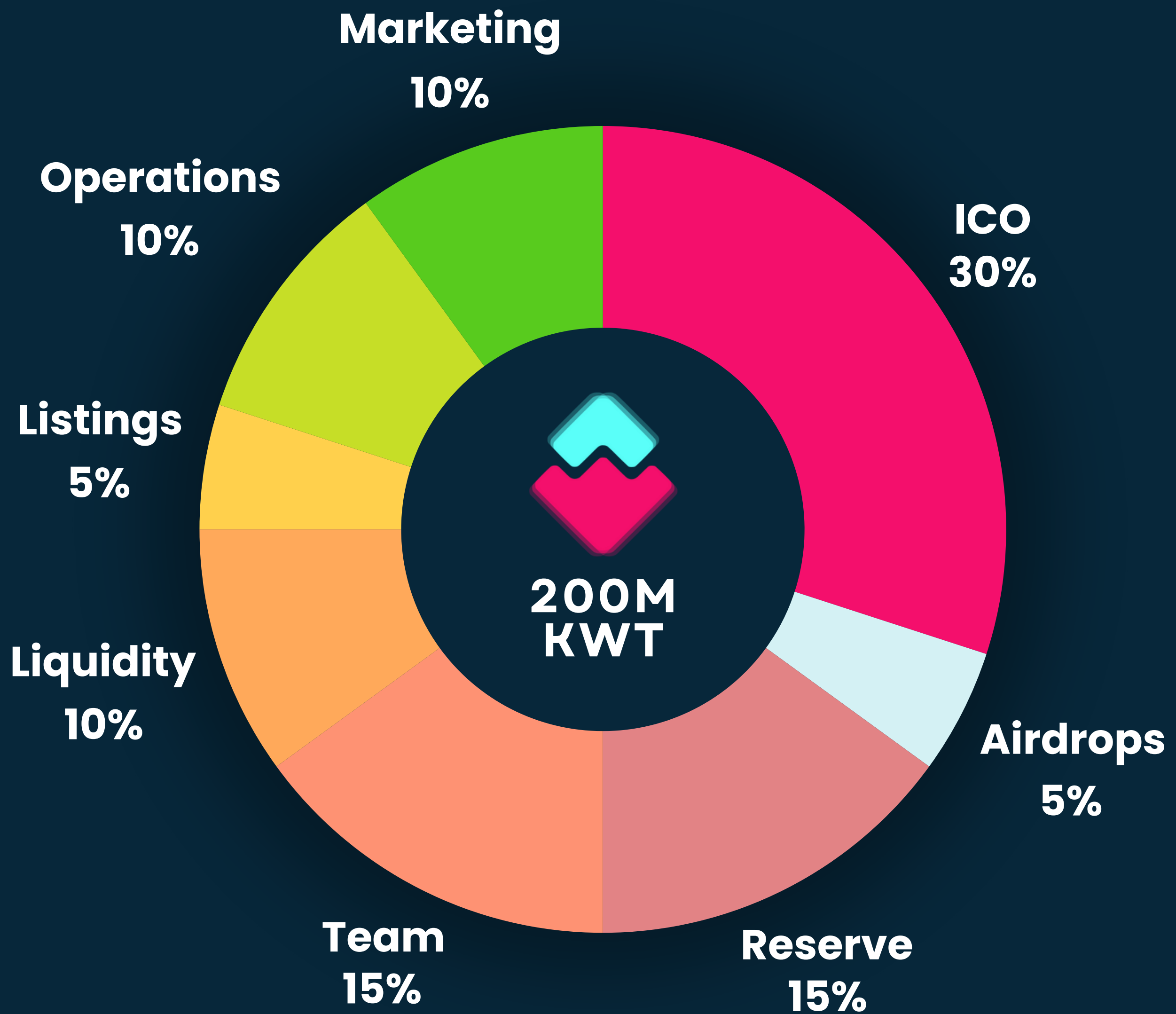

Public Sale (ICO) with Seed Round
